NITAAC CIO-CS GWAC User Guide

CIO-CS ORDERING GUIDE

CIO-CS is a \$20 billion, 10-year Government-Wide Acquisition Contract (GWAC) designed for IT commodities and solutions. It's available to all federal civilian and Department of Defense agencies to meet critical mission needs and budget goals. CIO-CS encompasses IT Service Management (ITSM) and provides easy access to approved vendors at pre-negotiated rates. The contract is managed by the National Institutes of Health Information Technology Acquisition and Assessment Center (NITAAC).

CIO-CS Ordering Process

Orders under CIO-CS must comply with the fair opportunity requirements outlined in FAR 16.505. Additionally, Ordering Contracting Officers (OCOs) should adhere to their Agency's specific policies and procedures when placing orders under a GWAC. Once a procurement order is awarded, it should be sent directly to the Contract Holder, who must then upload the order into NITAAC's Electronic Government Ordering System (e-GOS) before processing it.

STEP 1

End User or Contracting Officer

1. Using market research, Contract Holder finds the best value.
2. Using CIO-CS Contract# [HHSN316201500042W](#), creates order.
3. Order is sent to Contract Holder.

STEP 2

CIO-CS Contract Holder

1. Order is verified.
2. Order is uploaded into the NITAAC e-GOS system.
3. Order is processed.
4. Equipment and services are delivered.
5. Agency or Contractor is invoiced.



CIO-CS INFORMATION

- ▶ CIO-CS is a Government Wide Acquisition Contract consisting of over 66 pre-competited Prime Contract Holders.
- ▶ Open to all Federal Agencies and approved contractors.
- ▶ Scope includes all in-scope IT products and product related services.
- ▶ Technology Refreshment Process (TRP) enables commodities to be added in real-time.

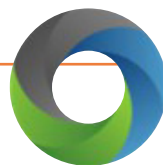
